JUDGMENT ENTRY

On April 21, 2017, this Court granted default judgment in favor of Plaintiff Floyd Scott and against Defendant CMI Waste, Inc. Intervening Plaintiff State of Ohio, Bureau of Workers' Compensation was granted default judgment against Defendant CMI Waste, Inc. on June 27, 2017. This matter came before the Court for a Damages Hearing on July 19, 2017 against Defendant CMI Waste, Inc. Plaintiff Floyd Scott and Intervening Plaintiff State of Ohio, Bureau of Worker's Compensation were present with counsel.

The Court, having considered the testimony and evidence presented at the hearing including, but not limited to, testimony from Plaintiff and exhibits consisting of medical reports and medical bills, hereby awards damages to Plaintiff Floyd Scott and against CMI Waste, Inc. in the total amount of \$8,219,126.14, reflecting an award of compensatory damages in the amount of \$2,269,126.14 for medical expenses, \$1,200,000.00 for lost wages, and \$250,000.00 for future medical costs, and non-compensatory damages of \$4,500,000.00 for pain and suffering.

The Court further awards damages against Defendant CMI Waste, Inc., to Intervening Plaintiff State of Ohio, Bureau of Worker's Compensation the amount of \$692,867.84 to satisfy its lien.

Plaintiff's claims against Defendants Bobbie Gobel and Winona McCarthy remain pending for resolution.

WHEREFORE, the Court hereby enters judgment against Defendant CMI Waste, Inc. and awards damages to Plaintiff Floyd Scott in the total amount of \$8,219,126.14 and damages to Intervening Plaintiff State of Ohio, Bureau of Worker's Compensation in the amount of \$692,867.84.

IT IS SO ORDERED.
